The Programme noted that v0.6 had previously been recommended by the NFTWG and v0.7 contained changes that had resulted from confirmed assumptions from Avanade/Helix.

	The Chair questioned if v0.7 contained changes to the scope of the document. The Programme confirmed that there are no changes to the scope, there is just a better understanding of responsibilities around how artefacts are going to be delivered to facilitate the testing. The Programme also detailed that Avanade/Helix, who this change pertains to, have reviewed the document and are comfortable with the deliverable.
	The Chair invited objections to the approval of the document, to which none were received.

Summary and next steps	The Small Supplier Representative noted that the TCR for PIT NF is due next week, and questioned if there have been any questions within NFTWG for the fact that all baseline documents are only just being approved.
	The Programme detailed that they could not confirm this within the session but will take an action away to check if any comments or queries were noted on this in the last NFTWG.
	ACTION: Programme to confirm if any comments or queries were raised in the last NFTWG on TCR for PIT NF. (SITAG06.1-01)
	The Larger Supplier Representative noted the ongoing delays in the approval process, which impacts timelines for suppliers and other parties involved in the programme.
	The Programme acknowledged these concerns but indicated that the NFT approach and plan has not changed in scope since an earlier version. The Programme mentioned that most test scenarios and cases have been approved, although some are still deferred, and the Programme is committed to addressing these concerns and following up on actions to confirm the overall industry view on this from NFTWG.
