| Headline Report and Actions | DECISION : The PSG Headline Report from the September PSG was approved with no amendments (PSG-DEC116). | |

| Ofgem Update | Ofgem provided a verbal update, reiterating their gratitude to everyone for their efforts in achieving M10. Ofgem also stressed the importance now of focusing on preparations for M11 and reminded participants that issues should be raised promptly with the programme and Code Bodies to ensure collaborative and timely resolutions. | |
| Programme Status Update | Programme provided an update on the Programme Status by workstream. The Programme is on track with any issues being closely monitored and addressed. Programme outlined several changes that have been made to the format of the slide. The following workstreams have closed and will be removed from the update from next month: Design Management SIT Data Code Drafting Non-SIT LDSO Qualification Testing The Migration and Supplier & Agent Qualification workstreams have also been divided into 2 workstreams, Readiness and Execution, and Qualification and Qualification Testing, respectively. Qualification testing is currently Red as progress was behind plan at the time of publishing the papers. Remedial action is underway at Elexon, and it is the intention of this status update to remain at Red until any recovery plans are shown to be being complied with. Elexon have provided more detail on Qualification testing, see Qualification Update section below. | |
| Qualification Update | Elexon provided an overview of Qualification testing progress. In the initial publication of the PSG papers, Wave 1 progress was significantly behind plan with a RAG status of Red. A recovery plan has been developed by the Code Bodies, which has now updated the RAG status to Amber, including: • Test set rationalisation • Engagement sessions with Wave 1 PPs • Sprint objectives and daily stand ups Elexon shared a revised plan and summary of the progress of each Wave 1 PP as well as the support provided. More detail can be found in the meeting slides. Elexon assured the DNO representative that the learnings from Wave 1 would be taken into future waves so that M11, Migration and future waves are not impacted. | |

Elexon also assured there would be a focus on ensuring DIP Onboarding issues do not impact future waves, following a query from the Programme.

Programme Update

Programme outlined the governance approach for the ELS operating phases as well as the planned targets for each phase, including:

- Daily Migrations
- Minimum MPANS needed to be operated within MHHS arrangements
- · Forecast phase length
- Forecast end dates

Elexon Hypercare Update

Elexon provided an overview of the Hypercare approach, model, governance, weekly metrics and Exit criteria. Elexon also provided an overview of the weekly incidents associated with the MHHS with a graph of the incident count.

Hypercare Update from Central Parties and LDSOs

Early Life and Hypercare Support

A verbal update on Hypercare and ELS was provided from the DNO, iDNO and RECCo representatives.

DNO: The DNO representative noted that Hypercare and ELS are going well, though M11 would be the next major test. Concerns were raised about two BAU change requests:

- **DCR005:** This relates to the extension of SIT Environments. Ambiguous wording has created confusion over whether only DIP or all systems must remain operational, potentially leading to unnecessary resourcing and risk.
- **CP1607:** This was approved but appeared to overlook St Clements' impact assessment, raising questions about whether technical definitions were sufficient for delivery by March 2026. It was stressed that while these issues were not immediately critical, they could affect resources and processes if not clarified.

iDNO: The iDNO representative confirmed things were generally stable, with LDSOs clear on their service management roles despite some teething problems and one design issue still under review. On DCR005, the concerns of the DNO representative were echoed.

| | RECCo : The RECCo representative reported that enquiry services were broadly stable post Go-Live. There had been some portal performance issues caused by re-platforming, but fixes were applied, and further investigation is ongoing to prevent recurrence as traffic grows post-M11. A few API call issues had also been resolved. |

| | M10 Work-Off Plan |
| | Programme provided a reminder on progress against the M10 Work-Off Plan. |
| | ACTION : The I&C Supplier representative asked whether the timeline of M10 Work-Off item 2 'Delivery of deferred P Flows (P0275, P0276 and P0277)' could be brought forward, noting the value of the data. Elexon advised that P0275 requires additional coding, and the next version will be produced towards the end of November, with a reasonable level of coverage provided then. A more complete version is expected by February, while timelines for the P276 and P277 flows will be clarified over the coming week. Elexon took an action to provide a more accurate update within the next week, with the intention of exploring the potential for bringing the delivery date forward (ACTION PSG49-02). |
| M11 Planning and Progress | The I&C Supplier representative asked for clarity on the timeline for Migration incentives. The plan is for Elexon to submit the final proposal for P487 to Ofgem in December 2025, with a decision expected in Q1 2026. The modification has broad agreement, though exception handling is still being finalised. Wider incentive arrangements may also be shaped by Ofgem's direction and licence conditions, which sit outside programme control. While the timeline cannot be brought forward, the Programme and Elexon are working closely to provide as much certainty as possible. |
| | M11 Decision Choreography and Exit Criteria |
| | Programme presented the proposed M11 Decision Choreography. There were no objections, and this was accepted as the approach. Meeting invites were shared following PSG. |
| | Programme also defined 24 M11 Acceptance Criteria to be met to achieve the milestone. These criteria are broken down in detail in the meeting slides with owners, due dates, RAG status and latest status. 9 of the 24 criteria have already been met through the delivery of M10. Programme is progressing well and is on track but acknowledging there are some teething issues in live operations. |
| | ACTION : Programme recommended PSG representatives to gather views from their constituents on the M11 Acceptance Criteria and provide feedback to Programme at pmo@mhhsprogramme.co.uk (ACTION PSG49-03). |
| Migration Readiness | Programme provided an update on Migration Readiness against the key milestones, as per meeting slides. The MCC is now fully mobilised and the the initial draft of the approach and orchestration for Migration Day 1 (24 October 2025) has been developed, and initial conversations have begun with Day 1 Participants. Sprint 0 is scheduled to commence on 24 September 2025 and more detail on the Participant journey and choreography can be found in the meeting slides. |
| AOB | ACTION : The DNO representative, noting that changes were planned to PSG reporting from November, requested guidance for the DNO and iDNO delivery dashboards for the November meeting. Programme agreed to provide some guidance (ACTION PSG49-04). |
| | Elexon addressed the single participant who rescinded their assurances regarding forward and reverse migration. The participant has been issued a formal breach notice under the BSC and must provide a credible rectification plan by next Monday, 06 October. The expectation is that the plan |

will ensure full compliance by M11. Otherwise, the participant could be placed in default and escalated back to the Panel. Elexon is coordinating closely with REC and Ofgem to ensure consistent action across codes and licence obligations. The immediate risk at M11 is low, as only a small number of MPANs will be migrated, but the risk would grow if left unresolved as migration volumes increase.

ACTION: The iDNO representative queried whether it was appropriate for the constituency representatives to be informed of the identity of the participant. Programme took an action to review and provide guidance for the constituency representatives and the participant (**ACTION PSG49-05**).
