Key Discussion Items

M11/M12 Decision Making Choreography	Programme provided a reminder of the M11/M12 Decision Making Choreography.
Programme View of Current M11/M12 status	M10 Work-Off Plan Programme gave the latest update on the M10 Work-Off Plan. M11 and M12 Status The Programme provided an update on the current status of M11/M12 with an overview against the M11 Acceptance Criteria. The overall view is that the Programme is on track to commence migration at M11/M12, with 11 of the 24 Acceptance Criteria met. The DNO representative requested visibility of the real migration numbers by MPID for LDSOs as early as possible. The programme confirmed that the migration team was finalising this data and would issue it shortly. The Programme also outlined open issues and key risks related to ELS and M11 – M15, and an update on the risk glidepaths to M10 and M11 with 11 key actions and plans for reducing the risk profile. Programme also provided this detail in a visual POAP.
