Headline Report and Actions	The Programme opened the meeting and ran through the agenda and requested approval of the Headline Report of the previous meeting.
	<b>DECISION:</b> The Chair, acting with delegated authority of the MHHS Senior Responsible Owner (SRO), approved the headline report of the previous meeting with no amendments. <b>(SITAG-DEC87 – recording timestamp 00:04:10)</b> .
	The Secretariat highlighted no ongoing actions; no comments or questions were received.
	The Programme provided an update on SIT-A Environment Closure.
	A PP asked how the SIT-A environment closure relates to CR63 and DCR005 discussions about extending provision for production testing. The Programme responded stating these are standalone decisions. CR63 was moved to enduring governance and does not affect the SIT-A closure. Reuse of environments is possible under enduring governance, but the programme cannot control future use. The Programme further clarified that that environments won't be kept warm for potential future changes.
SIT-A Environment Closure	A PP raised a question asking what happens to the data within SIT-A, especially considering expired data sharing agreements. The Programme replied stating that data must be expunged by participants. Much of it was real production data, and not suitable for future testing. Any future use would require a new data strategy. RECCo added that the DIP Manager noted this and will look to issue comms regarding SIT-A data handling.
