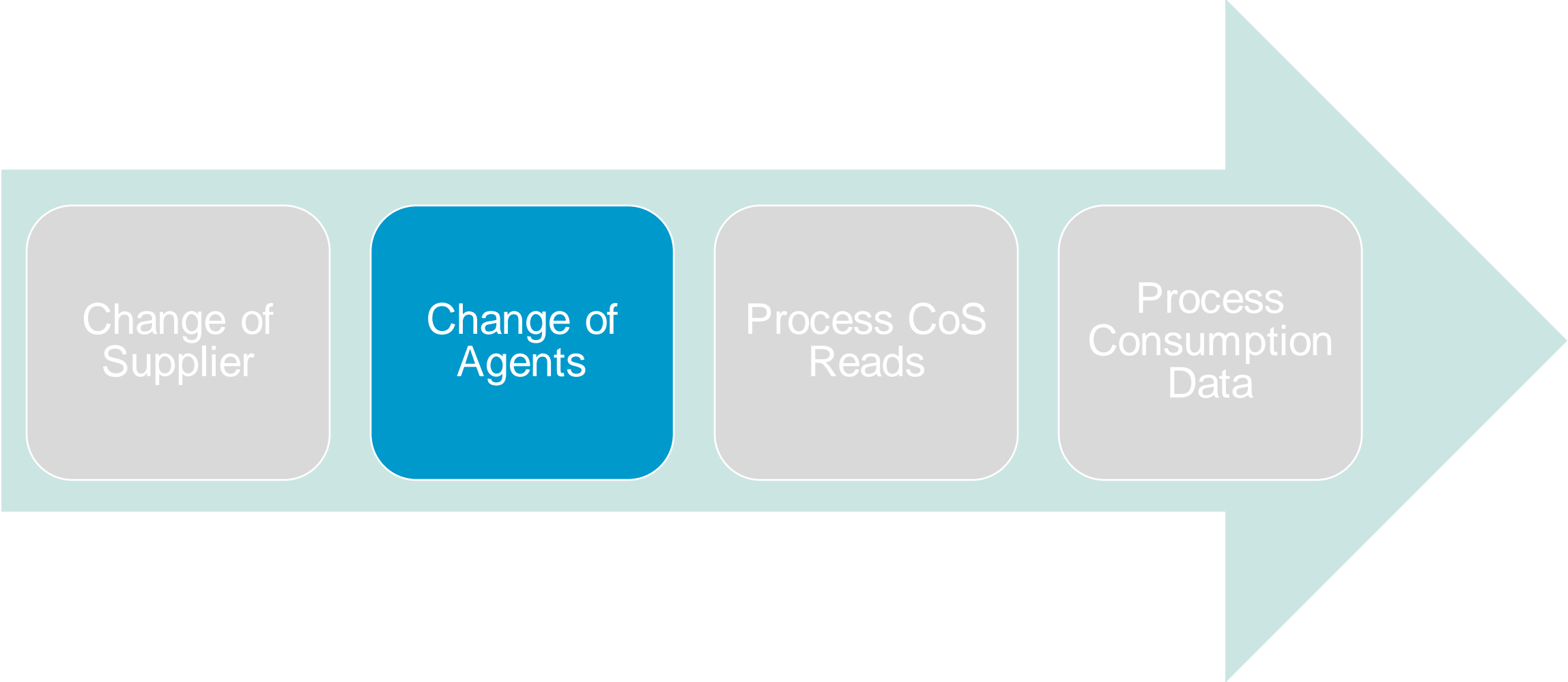


Switching Supplier Process

- REGS issues Proposed Appointment Request (IF-033)
- Metering Service Responds (IF-034)
- REGS issues Appointment Request Response (IF-035)



Deappoint Outgoing MS

- REGS issues Deappointment Notification (IF-037)
- To outgoing MS
- To Outgoing Supplier,
- To LDSO and EES



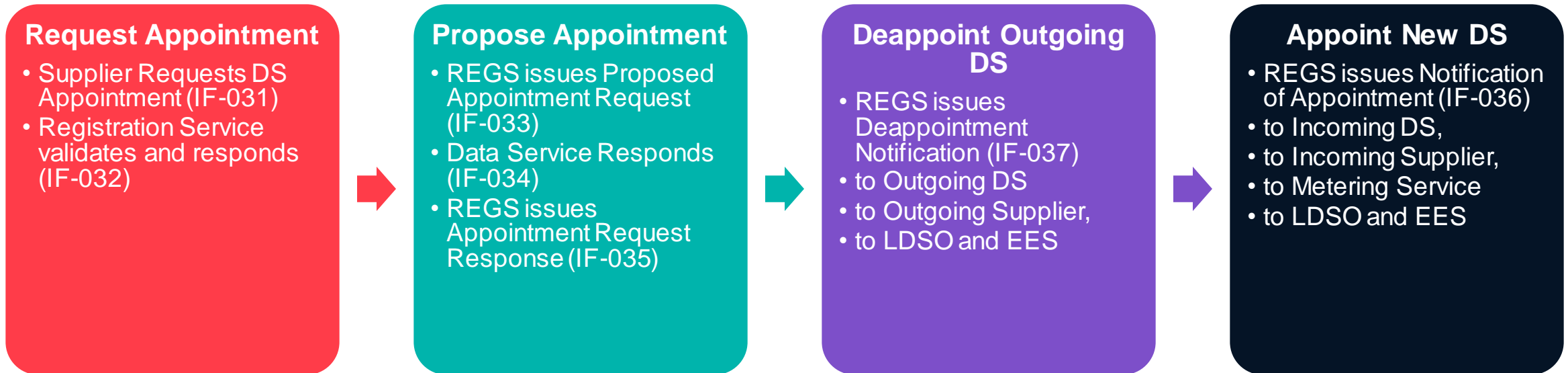
Appoint New MS

- REGS issues Notification of Appointment (IF-036)
- To Incoming MS,
- To Incoming Supplier,
- To Data Service,
- To LDSO and EES

Change of Agents - Data Service

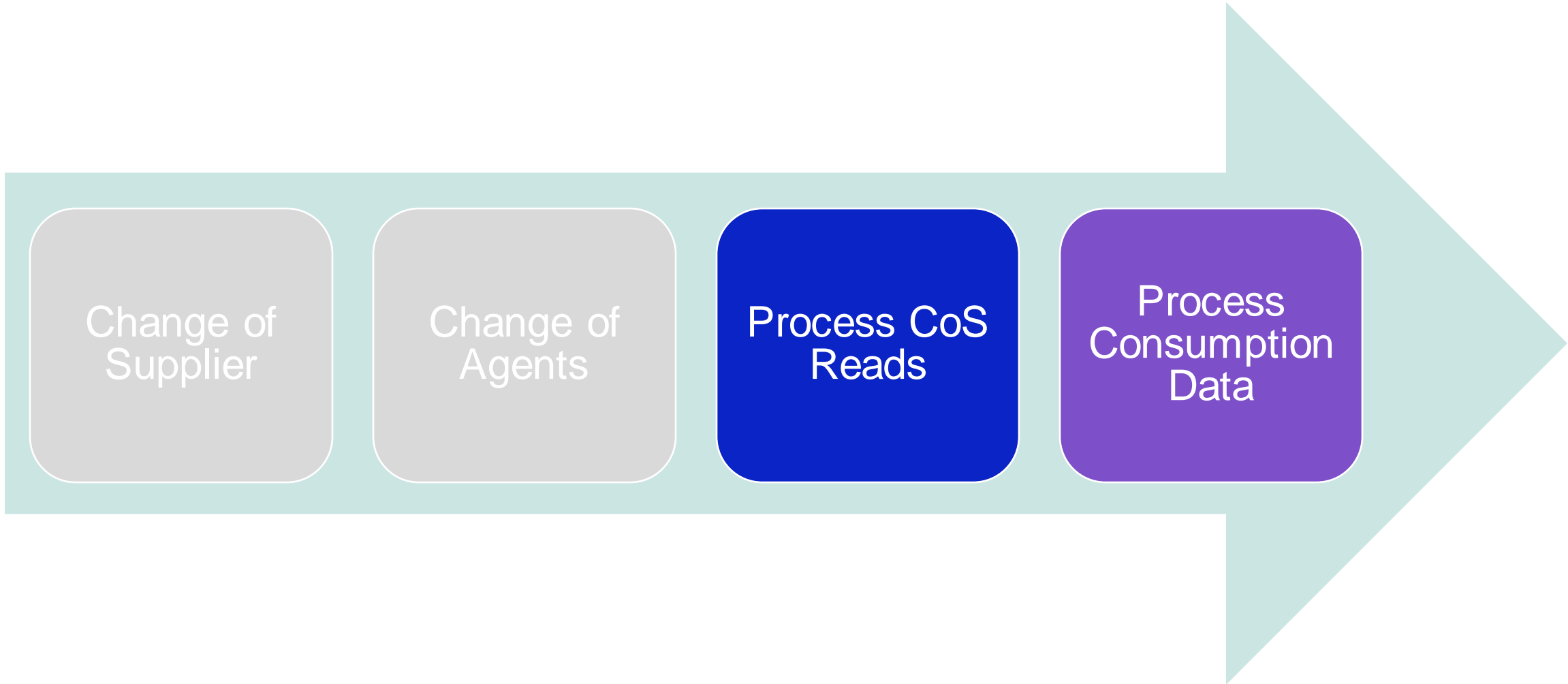


Data Services are appointed at Midnight Clock Time, in alignment with Supplier Registration

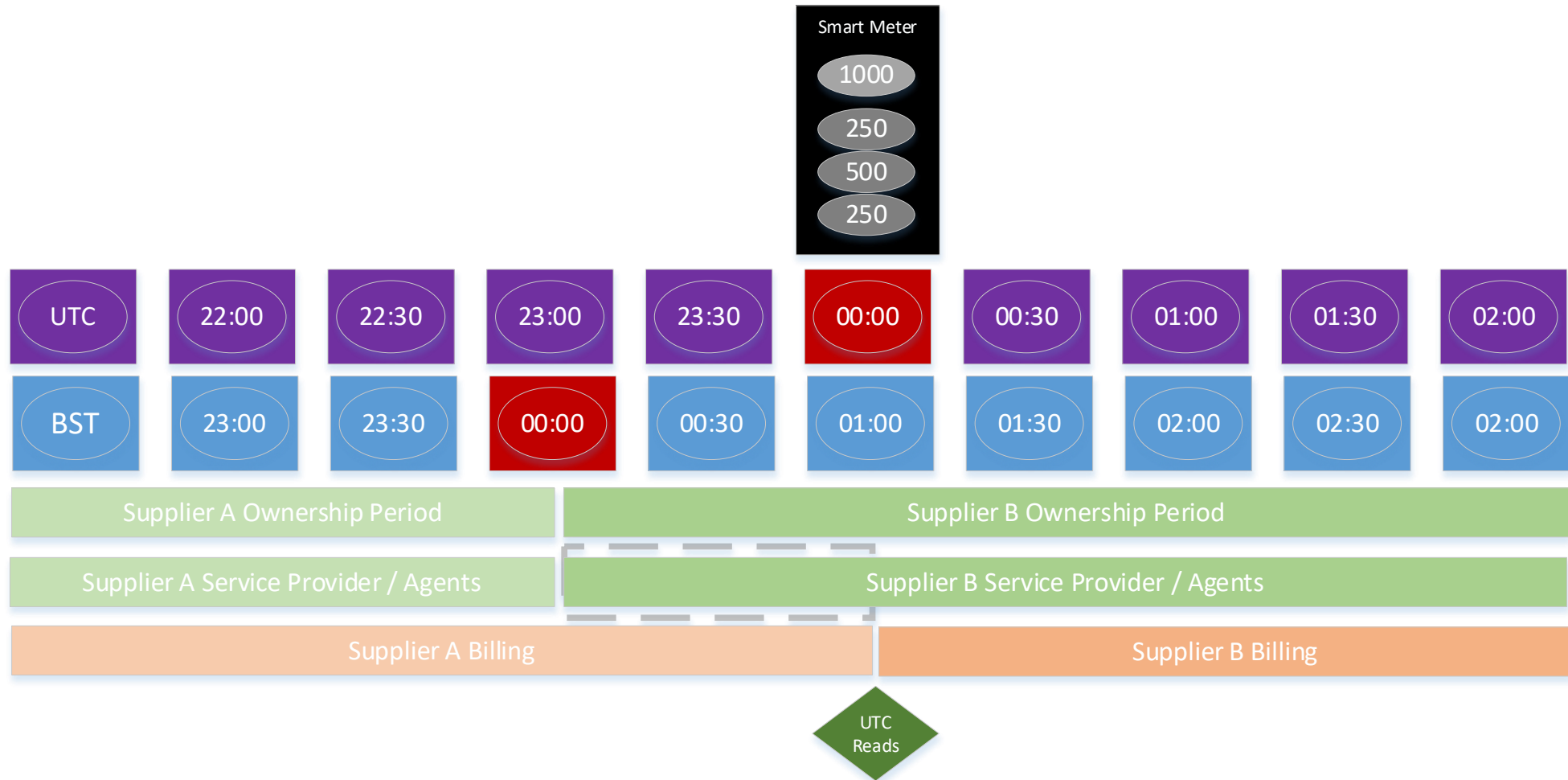

Transfer Reads

Smart Meters

- SMART Change of Supplier/Change of Service Cumulative and Register Reads are readings taken from the meter or estimated; and should be considered to have been taken at Midnight UTC.

Advanced Meters

- The industry convention that currently exists for Advanced Meters is to work solely in consumption, although accessing the meter to take register reads is not precluded. This will remain the case in the MHHS world.

Traditional Meters

- For Traditional meters, the existing process using the D0010s will continue, with the outgoing Data Service responsible for managing and distributing the reads



Transfer Reads – Smart Meters

Read Availability

- Both Suppliers and both Data Services will have access to the Cumulative and Register Reads at Midnight UTC on the day of a Switch

Outgoing Data Service

- Where available, the outgoing Data Service will publish Actual Cumulative and Register Reads on the IF-041
- Where Actuals are not available the outgoing Data Service will generate estimated cumulative reads and issue those on the IF-041

Incoming Data Service

- The incoming Data Service will compare and validate the PUB-041 they receive from the outgoing Data Service against the reads they have recovered and will send their own IF-041 to the incoming Supplier

Outgoing Supplier

- The outgoing Supplier will compare and validate the PUB-041 they receive from the outgoing Data Service against the reads they have recovered (or estimated) and will send a D0010 to the incoming Supplier

Incoming Supplier

- The incoming Supplier receives two PUB-041s and one D0010 and evaluates them.
- The incoming Supplier should initiate the D300 process if there is any concern around the consistency of readings or consumption data available to them



Consumption Data

The Outgoing Data Service is responsible for the collation and publication of consumption for the full UTC Day of the Switch

- This requires the IF-021 to be split in the event of a Change of Supplier during British Summer Time
- The Consumption Data for the settlement periods prior to the de-appointment date/time should be shared with the Outgoing Supplier
- Consumption Data between the de-appointment date/time and the end of the UTC day should be shared with the Incoming Supplier and Incoming Data Service

- The exception to this is where there is no outgoing Data Service (e.g. at migration)
- In this instance the Incoming Data Service will be responsible

- All IF-021s are to be routed to Elexon Central Settlements as well
- MDS and LSS will accept data from the **incoming** Data Service where there is **no outgoing** Data Service

- To facilitate correct routing of the IF-021 we are making Block B002 Incoming Supplier Information Mandatory in the IF-037 (Notification of Change of Service for [DSDApp] events when the reason code is CSUPP



Summary of the solution introduced by CR036

- ✓ Agent Appointment Periods are in clock-time, unchanged from the process today
- ✓ Agent Appointment & Supply Ownership periods are aligned
- ✓ Data Services to be responsible for the collation and publication of consumption for the full UTC day
- ✓ This requires the IF-021 to be split in the event of a Change of Supplier during British Summer Time
- ✓ No change to the existing Change of Supplier/Service read convention as previously described in the baselined design
- ✓ Settlement is accurate, in that consumption data is provided (actual or estimated using agreed Method Statement) for each and every HH period
